

CSM Contributions and Outcomes of the CFS Advisory Group and Bureau meeting of 21 November

The newly elected CFS Bureau met for the first time with the Advisory Group on 21st of November. The meeting's agenda items included an assessment of CFS 44 Plenary Session, a debate on the draft work plans of the different CFS workstreams and an update on the status of the CFS budget. The World Health Organization was also welcomed as a new member of the Advisory Group, replacing the High-Level Task Force on Global Food and Nutrition Security (HLTF). News on the translation of the HLPE Report on Nutrition and Food Systems

The full <u>HLPE Report on Nutrition and Food Systems</u> is still only available in English. Only the Executive Summary and Conclusions were translated before CFS 44 due to the financial constraints of the HLPE Budget. According to the CFS Bureau Outcomes of 21st of November the funding gap is closing with additional contributions of FAO, WHO and Monaco. The first OEWG meeting on nutrition is scheduled for 5 February 2018.

The CSM Youth Constituency has appointed its new Coordination Committee Members

The meeting of the CSM Youth Constituency took place on 7 and 8 of December in Rome. The meeting aimed at reflecting on the history, mandate, structure and functioning of the CFS and CSM; drafting and elaborating a vision, workplan and agenda of the CSM Youth Constituency; assessing how such a global governance space can also strengthen local/national/regional and other global dimensions of the struggles; and aimed at conducting the Coordination Committee members renewal process. The meeting selected by consensus the two new members of the CC for the Youth Constituency: Nasmin Choudhury, from WFF, India and Margarita Gomez, from CLOC/LVC, Argentina.



CSM Evaluation January - April 2018

The evaluation is carried out with the aim of assessing how the CSM is functioning in line with its founding document, guiding principles and mandate and functions. The Evaluation will assess CSM's strengths and weaknesses, challenges and potentials with regard to three areas: the internal dimension, the external dimension, and "visionary" dimension, as outlined in detail in the section on the scope. The evaluation will particularly look at the last three years, since the first Evaluation of the CSM carried out in 2014. The outcomes of this independent evaluation will provide the CSM with significant insights to self-reflect on the space and move forward to become as effective as possible in its future work in relation with the UN Committee on World Food Security.
